It is my pleasure to present the 2023 Imperial County Agricultural Commissioner's Crop and Livestock Report. This report is prepared in accordance with Sections 2272 and 2279 of the California Food and Agricultural Code, and summarizes the acreage, production, and value of agricultural commodities produced in Imperial County. All data shown represents gross production and values only, not the actual net profit. All prices and numbers are compiled from figures received from growers and producers.

Gross production for 2023 was valued at \$2,692,716,000. This is an increase of 2.36% compared to the 2022 gross value. In 2023, there were 578,659 harvested acres reported, up 4.80% from 2022.

Our number #1 commodity continues to be cattle followed by alfalfa, leaf lettuce, head lettuce, spinach, onions, broccoli, bermuda grass hay, carrots and alfalfa seed rounding out the top ten commodities.

Beyond production data, this report also highlights inspections, surveys, trapping, and other information for the Agricultural Commissioner and Sealer of Weights Measure's programs, as well as federal and state phytosanitary certificate data regarding exports from our county.

I am grateful to all the growers, processors, industry groups, and agencies who kindly submitted information for this report. I would also like to extend thanks to my staff, who without their hard work this report would not be possible.






