Description and Process

This Master Fee Schedule was adopted in accordance with Minute Order No. 20 on July 2, 2024 and Minute Order No. 21 on November 5, 2024.

Fees that are not established by California laws or regulations are determined by departmental cost studies and may in some cases include Consumer Price Index adjustment. The fee schedule can be revised annually or as needed by resolution of the Imperial County Board of Supervisors.

The fees in the schedule cover typical or general services. Any unique or additional services may be on a case-by-case basis and will be based on reasonable service cost at fully burdened rate per hour.
